CITY HALL, 100 MAIN ST, MILO, IOWA – MONDAY, DECEMBER 4, 2023

Milo City Council was called to order by Mayor Hall at 7:00 p.m. City Council answering the Clerk's roll call: Wadle, Uttley and Mason. Kinser and Rasmussen were absent. Mayor Hall administered the Pledge of Allegiance.

Motion by Mason and second by Wadle to approve agenda. Ayes: Wadle, Uttley and Mason.

Nays: none. Absent: Kinser and Rasmussen. Motion approved.

Motion by Mason and second by Wadle to approve the consent agenda to include all Council meeting minutes of November 13, 2023; and accounts payable from November 14 – December 4, 2023 in the amount of \$736,608.62. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved.

Crystal McIntyre, Warren County Supervisor, updated everyone in attendance of the happenings around Warren County including structural and safety changes to the Administration Building and having a deputy at the information desk; ongoing future planning for a County Wide EMS service with McIntyre meeting with the fire chiefs and ask for 2 representative to determine what is needed to be successful in rural Warren County and what the county wide EMS levy funding will be and how it will be utilized to help the rural EMS succeed; the Warren County Opioid Task Force and creating positions to help citizens; McIntyre then said that the County is considering buying, selling and trading County properties to better utilize facilities; McIntyre stated that the Board of Supervisors is changing to a 5-person board and each supervisor will need to be elected from their respective districts into their positions at the November 2024 election; no budget discussion for fy2025 have happened yet. Hembry asked about the new County Roads Shop and when it will be completed, McIntyre stated that there are ongoing issues that need to be resolved with the contractor.

Next, Mayor Hall administered the Oath of Office to the newly elected, Jeff Griggs and incumbent, Tangela Mason. Both elected will serve their respective Milo City Council terms from January 1, 2024 – December 31, 2027. The Clerk then administered the Oath of Office to incumbent Mayor Diane Hall who will also serve her next term of office from January 1, 2024 – December 31, 2027. Mayor Hall then thanked Councilperson Randy Uttley for

his years of service to the Milo City Council and to various boards and clubs within Milo.

Under old business, Council reviewed all items resulting in the following actions: Motion by Mason and second by Wadle to accept the Progress Meeting Notes of November 27, 2023. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Next, motion Wadle and second by Mason to approve Construction Monitoring Report No. 8. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Next, motion by Wadle second by Mason to approve Payment 8 to Blue Ribbon Builders in the amount of \$532.289.12. Aves: Wadle, Uttley and Mason, Navs: none. Absent: Kinser and Rasmussen. Motion approved. After discussion of the federal grant and the Iowa DOT bid letting for the Milo Multi-Use Path Project, motion by Mason and second by Wadle to approve Resolution 2023-33 approving the lowest bid contract with Elder Corporation in the amount of \$375,000 for construction of the Milo Multi-Use Path Project. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. The Clerk then reviewed trail funding commitments noting that the former Warren County Engineer, David Carroll, was instrumental in engineering the construction plans, easements and co-writing the \$230,000 grant which was a significant savings to the project. Clerk provided the letter of commitment from the Milo Lion's Club and noted that the grant documents listed that \$100,000 was promised by the Milo Lion's Club should the grant be successfully awarded. Clerk noted that the Milo Lion's Club has paid \$12,497 to date towards this obligation. The City of Milo has earmarked Local Option Sales Tax funds of \$25,000 for the construction of the trail and the remaining amount will be from local businesses, private donors and other areas to be determined. The Clerk also stated that McClure Engineering was awarded the wage compliance and construction engineering for the trail, they will also be tracking expenditures and submitting for reimbursement from the TAP grant. McClure Engineering's fee will not exceed \$42,000. The north concrete path connector was approved earlier at a cost of \$16,090. The City of Milo intends to pay funding \$83,090 (\$25,000 + \$42,000+\$16,090) from the Local Option Sales Tax (LOST) fund which is not property tax dollars. Mayor Hall noted that trail is a Lion's Club project that the City of Milo began assisting in 2018 by becoming the fiscal sponsor for the TAP grant application and award. When asked, Uttley shared that the Lion's Club trail

project started sometime in 2010 or 2011. After reviewing the north LED sign bids the item was tabled to the next meeting. Next, after review, motion by Wadle and second by Mason to approve the Warren County Sheriff's Contract for 5 years at \$25,192 annually. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Council then reviewed the Chapter 65 of the Milo Code and upon a motion by Wadle and second by Uttley, directed the Clerk to begin the process of changing the ordinance by creating a 3-way stop at 5th & Walnut Streets and replacing the yield sign with a stop sign at Spruce & 5th Streets. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Clerk shared that the city health insurance will be increasing 4% effective January 1, 2024 the monthly cost to Milo will be \$1,907.92 which specifically levied for employee benefits.

Council departmental reports: Kinser-public safety: absent - no report/questions. Rasmussen- utilities: absent - no report/questions. Wadle-streets: no report/questions. Uttley-parks: no report/questions. Mason-general – no report/questions. Doug Hembry, Operations Director presented bids for the storm siren electrical update, sand/salt bunker construction, 10 acre field drainage tile installation, and concerns about the City Park east playground area. Discussion followed resulting in these Council actions. Motion by Mason and second by Wadle to approve the bid of \$6,956 from Harvey Electric, Pleasantville, Iowa to install the electrical service for the storm siren which will also include future use of the Milo Public Library's addition. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Then, motion by Wadle second by Mason to approve the bid of \$19,700 from Cody Miller of 515 Builders LLC to construct the salt/sand bunker shelter. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Next, motion by Wadle second by Mason to approve the bid of not to exceed \$4,086 from Smith Fertilizer & Grain for the 10 acre tile drainage project. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. After further discussion concerning the condition of the east playground equipment, Hembry stated that he

will reinforce the rotting posts and Council asked that Hembry get bids for new playground equipment. Item to be placed on the future agenda.

Council reviewed all items under new business. Mayor Hall completed the second reading of Ordinance 2023-05 adding a new section regarding offsetting to the Iowa Department of Revenue debt owed to the City of Milo, Iowa. Motion by Mason and second by Wadle to approve the second reading of Ordinance 2023-05. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Then, motion by Wadle second by Mason to waive the third reading and direct the Clerk to publish the ordinance. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Then, motion by Mason second by Wadle to approve Resolution 2023-34 closing all City of Milo accounts with Greater Iowa Credit Union, Indianola, Iowa and moving the \$5.00 to People's Bank, Milo, Iowa. Roll call vote: Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Next, motion by Mason second by Wadle to approve the new home construction permit for 313 Peanut Street, Milo, Iowa. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. Then, motion by Mason second by Wadle to approve the tax abatement application for 313 Peanut Street, Milo, Iowa. Ayes: Wadle, Uttley and Mason. Nays: none. Absent: Kinser and Rasmussen. Motion approved. The Clerk then shared budget timeline information stating that property valuations will not be available until January 15, 2023 per the State of Iowa. Also, the Warren County Auditor will be responsible for sending out the City Council's determined levy amount for a new public hearing that will be held prior to the main budget hearing. The State of Iowa passed legislation taking away several levies available to cities, Clerk reported that Milo does not utilize these levies and this State of Iowa legislative change will not impact Milo as significantly as it will other communities. Next, the Clerk shared that there are several upcoming approved projects including the Milo Trail; field drainage tile installation awarded to Smith Fertilizer & Grain for \$4,086 paid from LOST or general funds; storm siren electrical install awarded to Harvey Electric for \$6,956 paid from LOST or general funds; construction of the sand/salt bunker shelter awarded to 515 Builders LLC for \$19,700 paid from Road Use Tax Funds and emergency funds; the north trail connector to the Milo Trail along the fence of the

Southeast Warren softball field parking area awarded to Pride Concrete for \$16,090 which will be paid from LOST funds; and the future stormwater update project which will be paid from ARPA funds.

There were no public comments. Mayor Hall again thanked Randy Uttley for his years of service to Milo City Council and wished in well in the future. Clerk reported that Southeast Warren Schools are not closing the daycare and were only doing a walkthrough to plan for possible future use of empty space for classrooms. Discussion turned to the baseball field update and how it was funded. Clerk contacted Delane Galvin, SEW Superintendent, who said that it was paid for with SAVE funds which are similar to the 1-cent sales tax LOST that the city utilizes for special projects. Mayor noted that the next Council meeting will be held Tuesday, January 2, 2024.

Health and safety reviewed the handout "Holidays Create Extra Stress for Workers." Motion by Wadle and second by Mason to adjourn at 9:05 p.m. Ayes: All present. Motion approved.

# MINUTES - CITY OF MILO ORGANIZATIONAL COUNCIL MEETING

CITY HALL, 100 MAIN ST., MILO, IOWA TUESDAY, JANUARY 2, 2024 AT 7:00 PM

Milo City Council was called to order by Mayor Hall at 7:00 p.m. Council answering roll call: Kinser, Wadle, Griggs and Mason. Absent: Rasmussen. Mayor administered the Pledge of Allegiance. Motion by Mason and second by Wadle to approve the agenda. Ayes-All present. Motion approved.

Motion by Wadle and second by Mason to set the regular Milo City Council meetings for the 1st Monday of each month at 7:00 p.m. and reserve the 3rd Monday of each month as an optional meeting. Ayes-All present. Motion approved. Motion by Mason and second by Kinser to designate the Indianola Record Herald as the official publication place for all official budgetary notices and ordinances except minutes, wages and council notices which will published in the Milo Newsletter. Further, Council meeting minutes will be posted under the government tab on the City of Milo website and physically posted at Milo City Hall, Milo Post Office, and Milo Public Library. Ayes-All present. Motion approved. Motion by Mason to designate People's Bank, Milo, Iowa and Community 1st Credit Union, Indianola, Iowa as the official bank depositories for the City of Milo, Iowa. Ayes-All present. Motion approved. Motion by Wadle and second by Mason to appoint Mercy Clinic, 307 East Scenic Valley Avenue, Indianola, Iowa as the Designated Physician/Facility for the City of Milo, Iowa. Ayes-All present. Motion approved. Motion by Mason second by Kinser to appoint Misti Kosman as City Clerk for the City of Milo, Iowa. Ayes-All. Motion approved. Motion by Mason and second by Wadle to appoint Stuyvesant, Strong, Krapfl & Carda Law Firm with locations in Indianola and Carlisle, Iowa as the Designated Attorney for the City of Milo, Iowa. Ayes-All present. Motion approved.

Mayor Hall appointed the following city positions: Tony Beck, Fire Chief; Derek Hommer, Alternate to the Emergency 911 Board; Tangela Mason, Mayor Pro Tem; Joe Kinser, Council Representative for Public Safety; Eric Rasmussen, Council Representative for Utilities; Erica Wadle, Council Representative for Streets; Jeff Griggs, Council Representative for Parks; Tangela Mason, Council Representative for General items.

Mayor Hall recognized the current appointments within the City's Boards and stated that the Board of Adjustments is seeking one additional member.

Mayor Hall then acknowledged the separate 28E Agreements that the City maintains with these entities: The Warren County Sheriff Contract which allows for a 0% annual fee increase unless renegotiated; the Warren County Building Rent contract is perpetual; Warren County Township (Belmont, Otter, Liberty and Union) respective contracts that expire June 30, 2025.

Motion by Mason second by Kinser to adjourn at 7:08 p.m. Ayes-All present. Motion approved. By Order of the Milo City Council

## NO PARKING ON CITY STREETS DURING SNOW EMERGENCIES

Milo Ordinance 69.11

When the National Weather Service predicts that two or more inches of snow or ice will fall or has fallen within the Milo area, street parking is not allowed.

The parking ban shall be in effect for a period of 24 hours after the snow ceases and the blowing stops or when the snow has been cleared from the city streets. Any car found in violation of this ordinance will be towed at the owner's expense.

CITY HALL, 100 MAIN ST, MILO, IOWA – TUESDAY, JANUARY 2, 2024

Milo City Council was called to order by Mayor Hall at 7:09 p.m. after the organizational meeting. City Council answering the Clerk's roll call: Kinser, Wadle, Griggs and Mason. Rasmussen was absent.

Motion by Mason and second by Wadle to approve agenda. Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved.

Motion by Kinser and second by Wadle to approve the consent agenda to include all Council meeting minutes of December 4, 2023; and accounts payable from December 5, 2023 – January 2, 2024 in the amount of \$86,361.07; November 2023 bank reconciliation report; November 2023 Warren County Sheriff's Report. Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved.

Under old business, Council reviewed all items resulting in the following actions: Motion by Kinser and second by Mason to approve wastewater project contract payments of \$5,364.40 and \$5,225.25 to Hall Engineering. Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved. Next, motion by Wadle second by Mason to approve trail project construction contract payment of \$3,684.46 to Elder Corporation. Discussion included the naming of the trail and the pre-construction meeting timeline. Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved. Then, motion by Kinser and second by Mason to table the North LED sign bids due to not having an updated bid. Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved. Afterward, motion by Mason and second by Kinser to rescind the approval from December 5, 2023 for the 5 year Warren County Sheriff's Contract due to Sheriff Carico adjustment to a 3 year contract. Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved. Then, motion by Wadle second by Mason to approve the 28E Agreement with the Warren County Sheriff's Office for a 3 year contract for law enforcement at a fee of \$25,192 annually with no increase. Roll call vote: Ayes: Kinser, Wadle, Griggs and Mason. Nays: none. Absent: Rasmussen. Motion approved.

Council departmental reports: Kinser-public safety: expressed concern about potholes on city streets that will have to be filled after snow season. Rasmussenutilities: absent - no report/questions. Wadle-streets:

no report/questions. Griggs-parks: expressed concerns of the mowing along the trail behind the upper ballfields and noted that there was asphalt and other items in the weeds that he removed last Fall. Clerk stated the Turner is willing to mow the edges if the debris was removed so he wouldn't ruin his mowers. Council stated the debris was left-over from the Lion's Club's pouring the path behind the ballfield. Griggs then asked about the City Park playground safety concerns. Clerk said that Doug Hembry said the playground can be mended in the short term and that he had met with Boland Recreation but had not received any bids or information vet. Discussion followed regarding City Park planning. Mason-general – no report/questions. Doug Hembry, Operations Director - no report as he was on vacation.

Council reviewed all items under new business and City Clerk gave Council a handout that explained revenue funding streams and the expenses that Milo uses including General Fund Levy, employee benefits levy, liability insurances; special revenues, proprietary funds and the restricted uses of each. Clerk also provided a printout of the Cityscape informational magazine from the Iowa League of Cities. Council reviewed the Local Option Sales Tax (LOST) deposits and investments. Discussion followed. Next, City Clerk provided an expense report for the wastewater project and an estimated expense report for upcoming city projects. Discussion followed. Kinser will contact Hembry regarding repurposing the trusses from the City Park shelter. Griggs asked about McClure Engineering's involvement in the trail. Clerk and Mayor explained that because it is a Transportation Alternatives Program (TAP) grant, it is required that an engineer oversee the construction portion of the project to ensure it is completed timely and within the guidelines set by the Iowa Department of Transportation. Also, to ensure proper wage compliance and implementing grant reimbursements. Clerk went on to explain that the engineering plans, DOT approval, easement procurement that has happened over the past few years was provided by David Carroll, former Warren County Engineer, as the fiscal sponsor for Milo. Then, after the final plan for the trail was approved by the Iowa DOT, the DOT took over and let the bids and will be involved to ensure compliance for the grant, it was then necessary for the City of Milo to hire an engineer to oversee the construction, wage compliance and grant reimbursement submissions.






