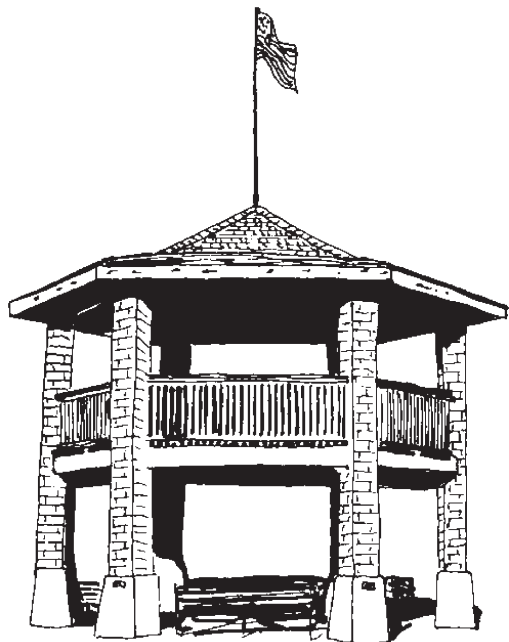

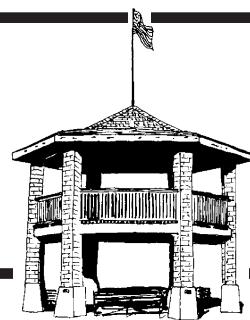

MINUTES of the CITY OF MILO COUNCIL MEETING

CITY HALL, 100 MAIN ST, MILO, IOWA –
MONDAY, FEBRUARY 19, 2024

Milo City Council was called to order by Mayor Hall at 7:00 p.m. City Council answering the Clerk's roll call: Wadle, Rasmussen, Griggs (joined by phone) and Mason. Kinser was absent. Mayor Hall administered the Pledge of Allegiance.

Motion by Mason and second by Wadle to approve the amended agenda to include a presentation to Randy Uttley and add a progress report and invoice to 6.b. Milo Multi-use Trail. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved.

Mayor Hall presented Randy Uttley with an award for his public service to the City of Milo as an elected councilperson. Uttley served three 4-year terms on the Milo City Council 2002-2005 and 2016-2023.

Motion by Mason and second by Wadle to approve the consent agenda to include all Council meeting minutes of February 5, 2024; and accounts payable from February 6 – February 19, 2024 in the amount of \$17,103.62; and the January 2024 Warren County Sheriff's Report. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved.

Council reviewed all old business items resulting in the following actions: Motion by Wadle and second by Rasmussen to approve contract payment in the amount of \$5,000 to Chariton Valley Planning & Development. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved.

Then, motion by Mason and second by Wadle to approve the Trail monthly progress reports for November/December 2023 and January 2024. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved. Next, motion by Griggs and second by Mason to approve Trail contract payments of \$2,563.75 and \$4,036.75 to McClure Engineering. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved.

Mayor Hall shared several bids for the north LED sign and discussed fundraising opportunities and possible funding from the City. Mayor Hall went over the bids and resolution and full color options with the capability of putting photos on the sign. Discussion followed. Clerk shared financial information and upcoming projects including the Trail, stormwater project, city park improvement

project, north LED sign. Item will be tabled to the next meeting.

Council departmental reports: Kinser-public safety: absent - no report/questions. Rasmussen- utilities: no report/questions. Wadle-streets: no report/questions. Griggs-parks: will speak later in the meeting about City Park updates. Mason-general – asked about concrete and rebar located at City dump. Hembry said that he is aware and that Warren County will be removing the concrete. The concrete came from SFG in Milo. Doug Hembry, Operations Director – presented bids from Pride Concrete and Country Concrete for the 1st Street/Belmont street paving project to be paid from Road Use Tax funds. Motion by Mason and second by Rasmussen to approve Country Concrete bid of \$48,991.25 for the 1st Street/Belmont street paving project. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved. Hembry stated that he will notify property owners of the date for street repairs to begin.

Council reviewed all new business resulting in the following actions: Motion by Wadle second by Rasmussen to approve Resolution 2024-02 adopting the Milo policy for the investment of public funds. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved. Then, motion by Mason second by Wadle to approve Resolution 2024-03 for the reallocation of funds from maturing Peoples Bank certificate of deposits. Ayes: Wadle, Rasmussen, Griggs and Mason. Nays: none. Absent: Kinser. Motion approved. Next, motion by Mason second by Wadle to approve April 26 - 27, 2024 as Milo City-Wide Cleanup. Council then discussed creating a possible food truck ordinance; item was tabled to the next meeting and Council will bring suggestions. Council reviewed the City Park Improvement Project which will include refurbishing the current shelter by replacing decaying posts with concrete block, new concrete floor, and siding; and then tying the roof line into the kitchen building and installing metal roofing. Also discussed was new playground equipment and moving the bathrooms and building new restrooms connected to the kitchen building. Then repurposing the former bathrooms into storage for Milo 4th of July Inc. Mayor Hall shared that she is attempting a Legacy Grant from Warren County Philanthropic Partnership. Discussion followed and item was tabled to the next meeting. Next, Mayor Hall explained the SWOT analysis and wish list for Milo. Discussion followed centering on upcoming projects and future needs/wants for Milo.

Call 811 Before You Dig

811 is the national number designated by the Federal Communications Commission to help protect homeowners and professional excavators from unintentionally hitting underground utility lines while working on digging projects – large and small.

Every digging project requires a call to 811. Hitting an underground utility line can harm the environment, cause serious personal injuries, disrupt service to an entire neighborhood and potentially incur fines and repair costs. Some common examples of when to call 811 are: installing a rural mailbox, putting up a fence, planting trees or shrubbery, building a patio or deck, excavating a new garden area, etc.

BURNING PROHIBITED

Milo Ordinance 105 & 135

City of Milo Ordinance 135.08 BURNING PROHIBITED. “No person shall burn any trash, leaves, rubbish or other combustible material...”. City of Milo Ordinance 105.05 OPEN BURNING RESTRICTED. “No person shall allow, cause or permit open burning of combustible materials...”. The complete ordinance is available at www.cityofmilo.com/government.

The Milo City Dump, located at the south edge of Milo, is open for citizens to use. Note that the only items allowed in the City Dump are concrete, dirt and yard vegetation (including trees) – please be sure to follow the posted guidelines! **Absolutely no treated lumber, building materials, or trash!**

MILO RECEIVES GRANT

\$500,000 for wastewater project

In November 2023, the City of Milo applied for the WTFAP (Wastewater and Drinking Water Treatment Financial Assistance Program) Grant to defray costs of the wastewater project that is slated for completion July 1, 2024. **The \$500,000 grant will be received in the next few weeks and applied to the outstanding loan balance.** This will allow for additional savings for Milo citizens of \$355,862.50 in interest and \$22,375 in service fees that will not have to be paid. This is an overall savings of \$878,237.50 for Milo citizens.

Milo Ordinance Chapter 55

After the long winter that we have had, Spring is a great time to walk your pets and play outside! Please be courteous of others who may also be enjoying the fresh air and springtime warmth. Always keep your pet on a leash and do not allow them to wander into others' yards.

There have been multiple complaints of dogs running loose within the city limits. This is dangerous for the dogs and for Milo citizens. Another issue has been excessive barking at all hours of the day and night. Not only are both of these issues disrespectful, but they are also unlawful.

MONDAY, MARCH 4, 2024

Milo City Council was called to order by Mayor Hall at 7:00 p.m. City Council answering the Clerk's roll call: Kinser, Rasmussen, and Mason. Wadle and Griggs were absent. Mayor Hall administered the Pledge of Allegiance.

Motion by Mason, second by Kinser to approve the agenda. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved.

Motion by Mason and second by Wadle to approve the consent agenda with a minor correction to the minutes to include all Council meeting minutes of February 19, 2024; and accounts payable from February 20 – March 4, 2024 in the amount of \$43,253.26. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved.

Council reviewed all old business items resulting in the following actions: Motion by Kinser, second by Mason to approve the wastewater project progress meeting notes of 2-26-2024. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. Next, Motion by Kinser, second by Mason to wastewater project construction monitoring report 9. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. Then, motion by Kinser, second by Rasmussen to approve wastewater project payment 10 in the amount of \$46,930.00 to Blue Ribbon Builders. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. Next, motion by Mason, second by Rasmussen to approve wastewater project contract payment of \$2,052.45 to Hall Engineering. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. After this, motion by Rasmussen, second by Mason to approve Amendment 1 to the McClure Engineering trail contract in the amount of \$5,900 due to construction change order 1 from Elder Corporation resulting in \$200 savings to the City of Milo. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. Mayor Hall noted that City Clerk has submitted a \$5,000 Warren County Philanthropic Grant for the north trailhead connectivity concrete and a \$95,000 Prairie Meadows Community Betterment Grant for trail construction. Council discussed the City Park update and Mayor Hall noted that she had submitted \$42,580 Prairie Meadows Grant, \$25,000 Warren County Economic Development High Impact Grant, and a \$5,000

Warren County Philanthropic Partnership Grant. Milo will find out if any were awarded in the next few months. Rasmussen asked when a potential start date is for the City Park updates. Mayor Hall said it would be after July 2024. Council departmental reports: Kinser-public safety: no report/questions. Rasmussen-utilities: no report/questions. Wadle-streets: absent-no report/questions. Griggs-parks: absent-no report/questions.

Mason-general: no report/questions. Doug Hembry-Operations Director-absent, no report.

Council reviewed items under new business resulting in the following actions: motion by Rasmussen, second by Mason to approve building permit application for 211 East Belmont, Milo, Iowa. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. Then, motion by Kinser, second by Rasmussen to approve Resolution 2024-05 investing funds into certificate of deposit with People's Bank. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved. Council reviewed Milo Code Chapter 136 and the sidewalk regulations policy. Discussion followed and a sidewalk improvement plan will be discussed again in the coming year. Next item discussed was the Milo garden positions. Motion by Kinser, second by Mason to approve Cali Searles as contract gardener for all Centennial Park garden areas and shrubs; and for the north trailhead garden; and facilitate the spring and fall clean-offs and the 3rd grade spring planting day for \$3,000 per season. Next, motion by Kinser, second by Mason to approve Cindy Rodgers as Main Street and City Park gardener. Ayes: Kinser, Rasmussen, and Mason. Nays: none. Absent: Wadle and Griggs. Motion approved.

There were no public comments. City Clerk provided a city project list and funding options. Discussion followed. Motion by Rasmussen, second by Mason to adjourn at 7:53 p.m. Ayes: All present. Motion approved.

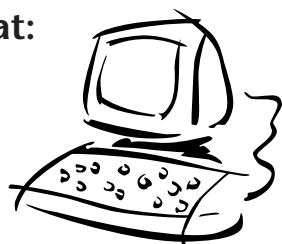

SIDEWALK AND TREE MAINTENANCE

Milo Ordinance 135,136 & 151

The City of Milo is providing an ordinance reminder to citizens that it is the property owner's responsibility to maintain trees, shrubs and sidewalks.

Trees which hang over sidewalks need to be trimmed to a height of 8 feet; if the tree hangs over the street it needs to be trimmed to a height of 15 feet above the surface of the street.

Property owners are responsible for sidewalk installation for new homes; and for all sidewalk maintenance including repairs and ensuring the sidewalk is clear of debris and vegetation. The complete Milo City Ordinance Chapters 135, 136 and 151 are available at City Hall or online at cityofmilo.com/government.

After putting your effort into trimming branches, raking grass/leaves and fixing sidewalks on your property; please remember the Milo City Dump, located south of Milo, is open for citizens to use. Note that the only items allowed in the City Dump are concrete, dirt and yard vegetation (including trees) – please be sure to follow the posted guidelines! **Absolutely no treated lumber, building materials, or trash!**

JUNK VEHICLES PROHIBITED

Milo Ordinance Chapter 51

This article is a reminder to Milo citizens that there is a law prohibiting junk and junk vehicles.

Ordinance § 51 Junk and Junk Vehicles states that it is unlawful for any person to store, accumulate, or allow to remain on any private property within the corporate limits of the City any junk or junk vehicle. Please note that “junk vehicle” means any vehicle legally placed in storage with the County Treasurer or unlicensed and which has any of the following characteristics: broken glass, broken or loose parts, habitat for nuisance animals or insects, flammable fuel, inoperable, defective or obsolete condition. Licensing of such vehicle shall not constitute a defense. A “vehicle” is every device that a person or property can be transported in without use of human power such as: automobile, motorcycle, tractor, buggy, farm machinery, etc. The complete ordinance is available for review online at www.cityofmilo.com/government.
